## **Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated December 06, 2023, placed the rating(s) of Vijay Engineering Works (VEW) under the 'issuer non-cooperating' category as VEW had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VEW continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 21, 2024, October 31, 2024, November 10, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
