Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 18, 2023, placed the rating(s) of Shradha Agencies Private Limited (SAPL) under the 'issuer non-cooperating' category as SAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 02, 2024, September 12, 2024, September 22, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Shradha Agencies Pvt. Ltd. (SAPL) which was originally incorporated as a sole proprietorship firm in 1992 by the name of Shradha Agencies was later reconstituted as a private limited company in 1996. It is a part of the Shradha group of Kolkata which has been promoted by Late Dr. C. L. Arora during early 1970 with primary interest into trading and logistics. Currently, the company is being managed by Shri Rajeev Arora (son of Late Dr. C. L. Arora). The company currently functions as a distributor of FMCG products, Mobile handsets and accessories, Pens and Safety Matches across the state of West Bengal (WB).
