## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 08, 2023, placed the rating(s) of Sri Laxmi Enterprises (SLE) under the 'issuer non-cooperating' category as SLE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SLE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 23, 2024, November 02, 2024, November 12, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

#### **About the Firm**

Sri Laxmi Enterprises (SLE) has been incorporated by Mr Om Prakash Agarwal and his family members in the year 2003. The firm is engaged in cotton ginning and pressing with installed capacity of 750 MT per annum. The firm primarily sources its raw material, Kapas, from local farmers in Telangana and sells its finished product in the states of Telangana, Maharashtra, Madhya Pradesh and Tamil Nadu.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of SLE to the 'issuer not-cooperating' category vide press release dated November 25, 2024 on account of its inability to carryout review in the absence of requisite information from the firm.
