Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated December 11, 2023, placed the rating(s) of Boss Pharma (BSP) under the 'issuer non-cooperating' category as BSP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BSP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 26, 2024, November 05, 2024, November 15, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

About the Firm Boss Pharma (BSP), based in Baddi, Himachal Pradesh was established in March 2006 as a partnership firm. The firm is currently being managed by Mr. Pankaj Nandwana and Mr. Rajat Nandwana as its partners. BSP is engaged in manufacturing of pharmaceutical formulations in the form of powder namely paracetamol, diclofenac sodium and vitamin C at its manufacturing facility located in Baddi, Himachal Pradesh.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of BSP into Issuer Not Cooperating category vide press release dated October 16, 2024 on account of its inability to carry out a review in the absence of requisite information.
