Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 30, 2023, placed the rating(s) of Shiva Wheels Private Limited (SWPL) under the 'issuer non-cooperating' category as SWPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SWPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 14, 2024, September 24, 2024, October 04, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Shiva Wheels Pvt. Ltd. (SWPL) was established as a partnership firm namely Shiva Auto in 1988. Since inception, the firm has been in two wheelers selling business. Later, in the year 2003, the firm was converted into a company and rechristened as SWPL. Presently, the company has two showrooms in and around Kolkata. The showroom at Ramgarh in Kolkata sells multi brand two wheelers, spare parts and accessories and the other showroom a B.T. Road is in authorised dealership of HMSI for the north part of Kolkata. Apart from this, the company has a workshop along with B.T. Road showroom.

Status of non-cooperation with previous CRA: Acuite has continued the rating assigned to the bank facilities of SWPL Into Issuer Not Cooperating category vide press release dated April 24, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
