### Rationale and key rating drivers

Reaffirmation of ratings of debt instruments and bank facilities of Infrastructure Leasing & Financial Services Limited (IL&FS) is considering continued instances of irregularities in debt servicing by the company.

Based on the petition filed by the Union of India, the National Company Law Tribunal (NCLT) vide its order dated October 01, 2018, suspended the erstwhile board and appointed a new board proposed by the Union of India, which took charge of the company from October 04, 2018. Per the order passed by the NCLT on October 09, 2018, the newly constituted Board of Infrastructure Leasing and Financial Services Limited (IL&FS) was empowered to replace the directors of subsidiary companies of IL&FS including IFIN. IL&FS' new board has been working on the IL&FS Group's resolution plan.

As part of the resolution process, the company's new board of directors submitted several progress reports to the NCLT, including a framework for a resolution plan and process, steps undertaken for monetisation of assets, appointment of consultants, and classification of group entities based on their abilities to meet financial and operational obligations, measures for cost optimisation and protocol for making payments beyond certain limits. The company has been making some recoveries and the funds are used for making payments mostly to meet operational expenses to ensure its going concern status.

### Rating sensitivities: Factors likely to lead to rating actions

- Timely debt servicing for at least three consecutive months.
