Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated December 20, 2023, placed the rating(s) of Lalit Polyplast Private Limited (LPPL) under the 'issuer non-cooperating' category as LPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 04, 2024, November 14, 2024, November 24, 2024 and December 20, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings have been revised on account of non-availability of requisite information. Further it also considers ongoing delay in debt servicing as recognized from publicly available information i.e., e-auction notice issued by the lender.

Incorporated in 2014, Lalit Polyplast Private Limited (LPPL) was promoted by Mr. Lalit Kumar Jha and Mrs. Anubha Jha, is engaged in trading of polymers and plastic raw materials like Poly Vinyl Chloride (PVC) resin, PVC paste resin, polypropylene granules, high-density polyethylene granules, low-density polyethylene granules, and linear low-density polyethylene granules, plasticisers and other polymers. The products of the company are used in making plastic containers, pipes, tanks, lamination, automobile industry etc. The company has warehouses in Delhi, Bawana and Faridabad having storage capacity of 300 M.T., 300M.T. and 450 M.T. respectively.
