Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 02, 2024, placed the rating(s) of Sri Balaji Trading Corporation (SBTC) under the 'issuer non-cooperating' category as SBTC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBTC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 17, 2024, November 27, 2024, December 07, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sri Balaji Trading Corporation (SBTC) was promoted by Mrs. Potluri Sitaratnam in year 2011 as a sole proprietorship firm. SBTC is engaged in trading of cotton lint and cotton yarn. The firm primarily supplies cotton lint to one of its group companies; Vantage Spinners Private Limited (VSPL) which is engaged in manufacturing of cotton yarn and has an installed capacity of 31,500 spindles and also to other spinning units located in Krishna District, Andhra Pradesh.
