### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 09, 2024, placed the rating(s) of Padmavati Ginning And Pressing Private Limited (PGPPL) under the 'issuer non-cooperating' category as PGPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PGPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 24, 2024, December 04, 2024 and December 14, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Padmavati Ginning and Pressing Private Limited (PGPPL) was originally incorporated in 2000 by Mr. O. H. Agrawal, however, the control of the company was taken over by Mr. Shyam Sunder Goyal in August 2011. Post the takeover; the company resumed operations in November 2011. It is engaged in manufacturing of cotton bales through cotton ginning & pressing. The company operates 4 branches located in Maharashtra (Ralegaon, Bori, Parbhani and Tamsa) which does the work on job-work basis. The plant of the company is located in Dhule, Maharashtra.
