Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated January 04, 2024, placed the rating(s) of Khwahish Marketing Private Limited (KMPL) under the 'issuer non-cooperating' category as KMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 19, 2024, November 29, 2024, December 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

KMPL was incorporated in 2004 and is currently being managed by Mr. Prashant Sharma. The company is engaged in the trading of iron and steel products such as hot rolled coils.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of KMPL into Issuer Not Cooperating category vide press release dated July 17, 2024 on account of its inability to carry out a review in the absence of requisite information.
