Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 04, 2024, placed the rating(s) of P.D. Agro Processor (PAP) under the 'issuer non-cooperating' category as PAP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PAP continues to be non-cooperative despite repeated requests for submission of information through emails dated November 19, 2024, November 29, 2024 and December 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Rae Bareli (Uttar Pradesh) based, P.D. Agro Processor (PAP) was established in July, 2013 as a partnership concern, by Mr. Bhupendra Agrawal, Mrs. Kamla Agarwal, and Mrs. Kavita. The firm is engaged in processing of non-basmati rice. The manufacturing unit is located in Rae Bareli, Uttar Pradesh.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of PS into 'Issuer not-cooperating' category vide press release dated November 20, 2023 on account of non-availability of requisite information from the company.
