Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated December 27, 2023, placed the rating(s) of J.B. Gold Private Limited (JGPL) under the 'issuer non-cooperating' category as JGPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JGPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 11, 2024, November 21, 2024, December 01, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company also started in-house manufacturing of gold & diamond jewellery in FY14 under its own brand name 'Kiyan'.
