### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 12, 2024, placed the rating(s) of Aries Corporate Services Private Limited (ACSPL) under the 'issuer non-cooperating' category as ACSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ACSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 27, 2024, December 07, 2024 and December 17, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Delhi based Aries Corporate Services Private Limited, was incorporated in September, 2003 as private limited company. The company is managed by Mr Manoj Bhardwaj and Mrs Alka Bhardwaj. The company is engaged in execution of electrification projects on turnkey basis, wherein, it caters to government entities. Further, the company is engaged in providing facility management services. ACSPL works for both public and private sector entities.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of ACSPL into 'Issuer not-cooperating' category vide press release dated October 11, 2024 on account of non-availability of requisite information from the company.
