Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 09, 2024, placed the rating(s) of Sri Sai Swarupa Seeds Private Limited (SSSSPL) under the 'issuer non-cooperating' category as SSSSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSSSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 24, 2024, December 04, 2024, December 14, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
