### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 09, 2024, placed the rating(s) of Rajarambapu Patil Sahakari Sakhar Karkhana Limited (RPSSKL) under the 'issuer non-cooperating' category as RPSSKL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RPSSKL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 24, 2024, December 04, 2024 and December 14, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the society

RPSSKL was incorporated by Late Rajarambapu Patil in 1968 under 'The Maharashtra Co-operative Societies Act 1960' as 'Walwa Taluka Sahakari Sakhar Karkhana Limited' to undertake sugar production in Sangli (Maharashtra). The name was subsequently changed to Rajarambapu Patil Sahakari Sakhar Karkhana Limited. RPSSKL is a part of the Sangli based 'Rajarambapu Group' whose diversified business profile comprises operations in sugar production, distillery, power generation, co-operative bank (Rajarambapu Sahakari Bank Limited), co-operative spinning mills, milk federation, soya bean extraction plant, educational institutes and petrol pumps.

**Status of non-cooperation with previous CRA:** ICRA has continued the rating assigned to the bank facilities of RPSSKL under Issuer Not Cooperating category vide press release dated July 12, 2024 on account of its inability to carry out a review in the absence of the requisite information from the society.
