Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 08, 2023, placed the rating(s) of Ashashree Frozen foods Private Limited (AFFPL) under the 'issuer non-cooperating' category as AFFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AFFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 23, 2024, November 02, 2024, November 12, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Incorporated in December 2014, Ashashree Frozen Foods Private Limited (AFFPL) was promoted by Shri Srikanta Kumar Khuntia and Smt. Anupama Khuntia for setting up a dairy processing plant in Odisha. AFFPL has already set up the dairy processing unit at Hatibari, Sambalpur with a processing capacity of 45,000 litre of milk per day. The commercial operation of the unit has started from January 14, 2018. AFFPL procures from locally and sells its milk products through distributors. The company has not availed moratorium from its lender that could be availed as per RBI circular.
