CARE Ratings Ltd. had, vide its press release dated January 02, 2024, placed the rating(s) of T M Motors (TMM) under the 'issuer non-cooperating' category as TMM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TMM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 17, 2024, November 27, 2024, December 07, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The showroom of the firm is located in Bharatpur and provides Sales, Services and Spare parts services to its customers.
