Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 17, 2024, placed the rating(s) of Alba Asia Private Limited (AAPL) under the 'issuer non-cooperating' category as AAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 02, 2024, December 12, 2024 and December 22, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Alba Asia Private Limited (erstwhile ABG LDA Bulk Handling Private Limited) (AAPL) is a Joint Venture between ABG Infralogistics Limited (ABG Infra) through its wholly owned subsidiary, ABG Ports Pvt. Ltd. and Louis Dreyfus Armateurs (LDA), France, holding 51% and 49% stake respectively. AAPL owns, operates, maintains and rents cranes of various types and capacity, which are used for different applications, mainly by the companies from the ports sector. The company at present has operations at Visakhapatnam Port and New Mangalore Port.
