Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 20, 2023, placed the rating(s) of Sri Jagannath Transport Corporation (SJTC) under the 'issuer non-cooperating' category as SJTC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SJTC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 04, 2024, November 14, 2024, November 24, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

SJTC was constituted as partnership firm via partnership deed dated April 11, 1992 by Golani family of Raipur, Chhattisgarh. The firm was reconstituted on April 01, 2017 on admission of a new partner Mr Devendra Golani. Since its inception, SJTC has been engaged in civil construction business in the segments like construction of road, bridges and repair and maintenance of track etc. The firm procures orders through tender and executes orders floated by the Indian Railways.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SJTC into Issuer Not Cooperating category vide press release dated December 20, 2023 on account of its inability to carry out a review in the absence of requisite information.
