### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 20, 2023, placed the rating(s) of Shri Vrindavanbihari Cold Storage Private Limited (SVCSPL) under the 'issuer non-cooperating' category as SVCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SVCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 04, 2024, November 14, 2024, November 24, 2024 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
