### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 12, 2024, placed the rating(s) of Tirumala Cashew Industries (TCI) under the 'issuer non-cooperating' category as TCI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TCI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 27, 2024, December 07, 2024 and December 17, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The firm is engaged in processing and trading of cashew nuts. The firm procures about 70% of its raw material, the raw nuts, from UAE and West African countries and the cashew kernels are procured from its associate entity, APM Cashew Industries.
