## **Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated January 16, 2024, placed the rating(s) of C. P. Sponge Iron Private Limited (CPSIPL) under the 'issuer non-cooperating' category as CPSIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CPSIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 01, 2024, December 11, 2024, December 21, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
