# Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 11, 2023, placed the rating(s) of Yours Projects Private Limited (YPPL) under the 'issuer non-cooperating' category as YPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. YPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 26, 2024, November 05, 2024, November 15, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

YPPL, incorporated in November 2009, belongs to the Kolkata Based BBA Group. The company has entered into a joint venture agreement with Oodalbari Company Ltd. (OCL, the owner of the land for the said project) for construction of a residential housing complex (by the name "Ananda") comprising of five towers at Jessore Road, Kolkata. CARE does not have any update on the latest developments in this regard.
