Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 29, 2024, placed the rating(s) of R. A. Shaikh Paper Mills Private Limited (RASPMPL) under the 'issuer non-cooperating' category as RASPMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RASPMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 14, 2024, December 24, 2024 and January 03, 2025 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company manufactures different varieties of kraft paper ranging from 120 to 250 Grams Per Square Meter (GSM) with various grades ranging from 16BF to 28BF (Burst Factor) which finds its application in the packaging industry especially for making corrugated boxes.
