Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 21, 2023, placed the rating(s) of Vardhman Spinners (VS) under the 'issuer non-cooperating' category as VS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 05, 2024, November 15, 2024 and November 25, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Vardhman Spinners (VS), based in Panipat, Haryana was established in May 2009 as a partnership firm. The firm is currently being managed by Mr. Ajay Kumar Jain, Mr. Hemant Kumar Jain, Ms. Shashi Jain and Ms. Dipty Jain as its partners. The firm is currently engaged in manufacturing of mink blankets and Upper shoe material at its manufacturing facility located in Panipat. The firm undertakes in-house dyeing and stitching of these blankets. The firm is also into trading of grey fabric with local procurement and sale of the same.

Status of non-cooperation with previous CRA: Acuite has continued the rating assigned to the bank facilities of VS into Issuer Not Cooperating category vide press release dated July 30, 2024 on account of its inability to carry out a review in the absence of requisite information.
