Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 22, 2023, placed the rating(s) of Renu Infrastructure Private Limited (RIPL) under the 'issuer non-cooperating' category as RIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 06, 2024, November 16, 2024 and November 26, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Later, in May 2017, it changed its constitution to private limited company and assumed current name. RIPL is registered 'AA' class approved contractor with Public Works Department (PWD), Rajasthan. The company mainly executes contracts for construction of roads, buildings, railway over bridge and road over bridge etc.
