Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 24, 2024, placed the rating(s) of Priyanka (india) Private Limited (PPL) under the 'issuer non-cooperating' category as PPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 09, 2024, December 19, 2024 and December 29, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Delhi based Priyanka India Private limited (PIPL), is a private limited company incorporated on March 12, 1983 by Mr Harbans Singh Sethi and Mrs Upneet Kaur Sethi. Currently, the company is being managed by Mr Iqbal Singh Sethi, Mrs Upneet Kaur Sethi and Mr Sarvraj Singh Sethi. PIPL is engaged in the manufacturing and trading of emergency relief items such as kitchen kit, hygiene kit, stationary kit, education kit. The company has 2 manufacturing facilities located in Manesar, Gurgaon and other at Mayapuri, Delhi.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of PIPL into Issuer Not Cooperating category vide press release dated July 19, 2024 on account of its inability to carry out a review in the absence of requisite information.
