### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 22, 2024, placed the rating(s) of Triveni Wires Private Limited (TWPL) under the 'issuer non-cooperating' category as TWPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TWPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 16, 2024, January 20, 2024 and January 22, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings have been revised on account of non-availability of requisite information.

Incorporated in the year 1981, TWPL is engaged in the manufacturing of galvanized iron wires, barbed wires, and chain links amongst others. The manufacturing facility of the company will be located at Butibori, Nagpur with an installed capacity to manufacture 36000 MTPA.

**Status of non-cooperation with previous CRA:** ICRA has continued the rating assigned to the bank facilities of TWPL under Issuer Not Cooperating category vide press release dated February 29, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
