#### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated December 19, 2023, placed the rating(s) of Ramesh Singh (RS) under the 'issuer non-cooperating' category as RS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 03, 2024, November 13, 2024, January 08, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Indore (Madhya Pradesh) based Ramesh Singh (RS) was initially formed in February 2009 by Mr Ramesh Singh with 8 others partners. However, in January 2018, 5 members retired and remaining partners Mr. Ramesh Singh, Mr Manjeet Singh Bhatia Mrs. Puneet Kaur Bhatia and Narmada Biofuel Pvt Ltd. agreed to continue business. The firm is engaged in the retailing of country made and Indian Made Foreign Liquor (IMFL) in Madhya Pradesh. The firm has licenses for 5 shops for FY 2019-20.
