Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 19, 2023, placed the rating(s) of Mevada Oil Mill Private Limited (MOMPL) under the 'issuer non-cooperating' category as MOMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MOMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 03, 2024 and November 13, 2024, November 23, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The firm was engaged in the business of production of refined groundnut oil and trading in all types of Edible Oil and Oil Cakes. During October 2016, the Proprietorship firm was reconstituted as "Mevada Oil Mill Private Limited" and is now engaged into manufacturing of cotton wash oil, crude corn oil and oil cakes as well as trading in all kinds of edible oil, non-edible oil and oil cakes.
