### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 05, 2024, placed the rating(s) of New Front Housing (NFH) under the 'issuer non-cooperating' category as NFH had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NFH continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 20, 2024, November 30, 2024, and December 10, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings have been revised on account of non-availability of requisite information.
