Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated January 10, 2024, placed the rating(s) of Pathankot Vehicleades Private Limited (PVPL) under the 'issuer non-cooperating' category as PVPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PVPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 25, 2024, December 05, 2024, December 15, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of PVPL have been revised on account of non-availability of requisite information.

Pathankot Vehicleades Private Limited was incorporated as a private limited company in 1995 and started operations in 1997. It is a part of the Vehicleades Group of Jammu & Kashmir, promoted by Mr. Devender Rana and Mrs. Gunjan Rana. PVPL is an authorized dealer for the sale of passenger vehicles of Maruti Suzuki India Ltd. The company is engaged in the sale of passenger vehicles, servicing of vehicles, sale of spare parts and sale of pre-owned cars, having its showrooms across states of Punjab and Himachal Pradesh. The group concerns of the company include AAA Vehicleades Private Limited (CARE D: Issuer not Cooperating), J&K Vehicleades Private Limited, Jamkash Vehicleades Private Limited, Jamkash Vehicleades (Kashmir) Private Limited and Kangra Vehicleades all of which are engaged in the dealership of passenger and commercial vehicles of MSIL.
