Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 14, 2023, placed the rating(s) of Rajnigandha Marbles Private Limited (RMPL) under the 'issuer non-cooperating' category as RMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 29, 2024, November 18, 2024 and January 07, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings for RMPL have been revised on account of non-availability of requisite information.
