### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 28, 2023, placed the rating(s) of Riddhi Siddhi Cold Storage Private Limited (RSCSPL) under the 'issuer non-cooperating' category as RSCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RSCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 12, 2024, November 22, 2024, December 02, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Riddhi Siddhi Cold Storage Pvt Ltd (RSCSPL) was incorporated in August 2015 by one Mr Raja Chakraborty and Ms. K Chakraborty from Kolkata to set-up a cold storage and potato trading business. Afterwards the company started to install the cold storage service at Shamuktala in Alipourduar district of West Bengal. During March 2016 the company started weighbridge service at the site and during June 2016 the commercial operation of cold storage service and trading activities of potato has been started with an installed capacity of 27,500 MTPA. The day-to-day affairs of the company are looked after by Mr. Raja Chakraborty (Director) with adequate support from other director- Ms. K Chakraborty (wife of Mr Raja Chakraborty) and a team of experienced personnel.

**Status of non-cooperation with previous CRA:** Infomerics has continued the rating assigned to the bank facilities of RSCSPL into Issuer Not Cooperating category vide press release dated February 21, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
