Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 18, 2023, placed the rating(s) of Shubh Aluminium Private Limited (SAPL) under the 'issuer non-cooperating' category as SAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 02, 2024, November 12, 2024 and November 22, 2024 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Udaipur-based (Rajasthan) Shubh Aluminum Private Limited (SAPL) was incorporated in 2012 by 'Motawat family' along with Mr. Ashok Agarwal. SAPL commenced its commercial operation from September, 2015 onwards and is primarily engaged in trading of Iron & Steel, Aluminium scrap, Polyester Yarn and PET bottles.

Status of non-cooperation with previous CRA: CRSIL has continued the rating assigned to the bank facilities of SAPL into Issuer Not Cooperating category vide press release dated April 17, 2024 on account of its inability to carry out a review in the absence of requisite information.
