Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 17, 2024, placed the rating(s) of Joginder Singh (JS) under the 'issuer non-cooperating' category as JS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 02, 2024, December 12, 2024, December 22, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

M/s Joginder Singh (JS) is a proprietorship firm established in 2008 by Mr. Joginder Singh (aged 65 years). The firm is engaged in providing services as transport contractor to Food Corporation of India (FCI) for the transportation of food grains from one centre of FCI to another centre of FCI in different districts of Himachal Pradesh and Punjab.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of JS into Issuer Not Cooperating category vide press release dated February 21, 2024 on account of its inability to carry out a review in the absence of requisite information.
