Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 04, 2024, placed the rating(s) of Sony Aircon (SA) under the 'issuer non-cooperating' category as SA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 19, 2024, November 29, 2024 and December 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sony Aircon was established in 1997 as a proprietorship firm by Mr Anurag Bansal. The firm is an authorised dealer of Daikin Industries, Ltd.'s Air conditioner and Tanishq Jewellery. The firm is engaged in trading and retail sale of Tanishq branded gold and diamond jewellery and Daikin branded electronic items like air conditioner. The firm currently owns one exclusive retail showroom for each brand located in Agra, Uttar Pradesh. The showroom also has attached workshop facility for the post sales services of air conditioners. The firm sells its products in the domestic market in the regions of Uttar Pradesh and Uttarakhand.

Status of non-cooperation with previous CRA: BRICKWORK has continued the ratings assigned to the bank facilities of SA into 'Issuer not-cooperating' category vide press release dated November 14, 2024 on account of non-availability of requisite information from the company.
