### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 08, 2023, placed the rating(s) of Himalayan Road Construction Private Limited (HRCPL) under the 'issuer non-cooperating' category as HRCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HRCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 23, 2024, November 02, 2024, November 12, 2024 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Himalayan Road Construction Private Limited (HRCPL) was incorporated in the year 2009 and currently; the company is being managed by Mr. Pawan Kr Agarwal, Mr. Apurba Guha, Mr. Anil Kr Agarwal, Mr. Somdeep Guha, Mrs. Nirmala Devi Agarwal and Mrs. Nandita Guha. Since its inception, the company has been engaged in civil construction activities in the segment like construction of roads. HRCPL is classified as 'Class 1' contractor by the West Bengal Government which enables it to participate in higher value contracts. HRCPL secures work contracts through tender and executes orders mainly for various departments of West Bengal Government. The company has availed the moratorium for interest on working capital under the terms of recent RBI circular.

**Status of non-cooperation with previous CRA:** India Ratings has continued the rating assigned to the bank facilities of HRCPL into ISSUER NOT COOPERATING category vide press release dated May 15, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.

CRISIL has continued the rating assigned to the bank facilities of HRCPL into ISSUER NOT COOPERATING category vide press release dated November 11, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
