### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated December 22, 2023, placed the rating(s) of Soham Cold Storage And Chilling Plants (SCSCP) under the 'issuer non-cooperating' category as SCSCP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCSCP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 06, 2024, November 16, 2024 and November 26, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

SCSCP was established in July 2016 by Mr. Pravesh Gupta and his wife Mrs. Manju Gupta. SCSCP was established to provide cold storage facilities. The plant is located in Agra which contributes significantly to agricultural production of the state.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of SCSCP into 'Issuer not-cooperating' category vide press release dated November 11, 2024 on account of non-availability of requisite information from the Firm.
