### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 13, 2023, placed the rating(s) of Vishal Coaters Private Limited (VCPL) under the 'issuer non-cooperating' category as VCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 28, 2024, November 07, 2024 and November 17, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of VCPL have been revised on account of non-availability of requisite information.
