Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 02, 2023, placed the rating(s) of Proventus Ager India Private Limited (PAIPL) under the 'issuer non-cooperating' category as PAIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PAIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 17, 2024, September 27, 2024, October 07, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Vadodara-based PAIPL is promoted by Mr Doraprasad Nimmagada (promoter of Jay Polypack Private limited and Jay Agro Industries) in January 2015. The board of directors of PAIPL comprises of Mr Doraprasad Nimmagada, his wife Mrs Aruna Nimmagada and his son Mr. Vijay Nimmagada. PAIPL has commenced the trading operations during FY16 (refers to the period April 1 to March 31) from May 2015. The company primarily procures Agrochemicals, Pesticides and Insecticides from its group entity i.e. Jay Agro Industries and markets it through dealers across the country.
