### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 28, 2023, placed the rating(s) of Mohan Motor Udyog Private Limited (MMUPL) under the 'issuer non-cooperating' category as MMUPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MMUPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 12, 2024, November 22, 2024, December 02, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Mohan Motor Udyog Pvt. Ltd. (MMUPL), incorporated in 1986, is promoted by Mr. Sandip Kumar Bajaj (Managing Director) and Mr. Gaurav Bajaj (Executive Director & son of Mr. Sandip Kumar Bajaj. MMUPL was an authorised dealer of Sale & Service of Maruti Suzuki India Ltd (MSIL) till March 2014. After MSIL'S exit, MMUPL has entered into an agreement with Hyundai Motor India Limited (HMIL) as its authorised dealer. The group has an integrated mode of operations, functioning in various verticals of auto dealership business to provide one stop shop solution to its customers. It has service stations, spare parts distribution and vehicle finance which provide the customer with complete solution at single point.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of MMUPL into Issuer Not Cooperating category vide press release dated March 20, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
