Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 09, 2024, placed the rating(s) of MP Border Checkpost Development Company Limited (MBCDCL) under the 'issuer non-cooperating' category as MBCDCL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MBCDCL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 24, 2024, December 04, 2024 and December 14, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

MP Border is a Special Purpose Vehicle, sponsored by IL&FS Transportation Networks Ltd. (ITNL, rated CARE D; Issuer Not Cooperating) and Spanco in the ratio of 74:26, to perform up-gradation, modernization, construction, operation and maintenance of 24 Border Check Posts (BCPs) and two Central Control Facilities (CCFs) on Build, Operate and Transfer (BOT) basis for a period of 12.5 years starting from appointed date i.e. May 05, 2011. CARE does not have any update on the latest developments in this regard.
