### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 27, 2023, placed the rating(s) of Raja Poultry Farm (RPF) under the 'issuer non-cooperating' category as RPF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RPF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 11, 2024, November 21, 2024 and December 01, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the firm

Raja Poultry Farm (RPF) was established in the year 1992 and promoted by Mrs. Mangamma (proprietor). The firm is engaged in farming of egg, laying poultry birds (chickens) and trading of eggs, cull birds and their Manure. The firm sells its products like eggs and cull birds in, Assam, Kerala, Maharashtra and Tamil Nadu to retailers through own sales personnel and through some dealers. The firm mainly buys chicks (small chickens) from Venkateshwara Hatcheries Private Limited. The firm purchases raw materials for feeding of birds like rice broken, maize, sun flower oil cake, shell grit, minerals and soya from local traders. Moreover, in September 2016 the firm started commercial operation of solar roof top power plant with installed capacity of 1.5 MW.
