CARE Ratings Ltd. had, vide its press release dated January 11, 2024, placed the rating(s) of Versant Online Solutions Private Limited (VOSPL) under the 'issuer non-cooperating' category as VOSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VOSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 26, 2024, December 06, 2024, December 16, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
