Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 27, 2023, placed the rating(s) of Sachdev Steel Works Private Limited (SSWPL) under the 'issuer non-cooperating' category as SSWPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSWPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 11, 2024, November 21, 2024, December 01, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Sachdev Steel Works Private Limited (SSWPL) was initially established as a sole proprietorship firm (known as Union Enterprises) by Mr. Raj Sachdev in 1975. The firm was reconstituted as a Private Limited Company with the name being rechristened to current one in 1986. Currently, the second generation represented by Mr. Bharat Bhushan Sachdev (son of Mr.Raj Sachdev), manages the day-to day operations of the company. The company manufactures mild steel bars and rods wherein MS Billets/MS Ingots are used as the major raw material at its facility in the Adityapur Industrial Area of Jamshedpur, Jharkhand.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SSWPL into ISSUER NOT COOPERATING category vide press release dated April 08, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
