### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 31, 2024, placed the rating(s) of Mahashakthi Chemicals and Fertilizers Private Limited (MCFPL) under the 'issuer non-cooperating' category as MCFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MCFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 16, 2024, December 26, 2024 and January 05, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Mahashakthi Chemicals and Fertilizers Private Limited (MCFPL), was initially established as a Shree Chamundeswari Fertilizers and Chemicals Private Ltd and renamed as MCFPL. MCFPL was incorporated in November, 2012 and started its commercial operations from January, 2015 is managed by Mr. H.S. Chidananda and other eight directors. MCFPL is engaged in the business of trading and manufacturing of granulated fertilizers and soil conditioner. MCFPL product profile includes NPK (Nitrogen, potassium and phosphorus) of different grades like 17:17:17, 20:20:0, 20:10:10, 18:18:10, 10:20:10, 14:6:21 and 15:05:05.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of MCFPL under Issuer Not Cooperating category vide press release dated July 10, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
