CARE Ratings Ltd. had, vide its press release dated January 24, 2024, placed the rating(s) of M & T Constructions (MTC) under the 'issuer non-cooperating' category as MTC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MTC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 09, 2024, December 19, 2024 and December 29, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
