### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 29, 2023, placed the rating(s) of Ravji Manji Sorathia and Company (RMSC) under the 'issuer non-cooperating' category as RMSC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RMSC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 13, 2024, November 23, 2024 and December 03, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
