### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 09, 2024, placed the rating(s) of Sanee Infrastructure Private Limited (SIPL) under the 'issuer non-cooperating' category as SIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 24, 2024, December 04, 2024, December 14, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Bhopal-based (Madhya Pradesh) Sanee Infrastructure Private Limited (SIPL, CIN: U45203MP2002PTC015327) was formed in 2002 by Mr Nilay Jain and Mrs Nisha Jain as a private limited company to carry out the construction of building and roads. The company mainly executes contracts of construction & maintenance of roads majorly in the state of Madhya Pradesh.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of SIPL to 'Issuer Not Cooperating' category vide press release dated May 29, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
